COOKIE POLICY

This Cookie Policy explains how i r design FZ-LLC (“IRD”, “we”, “us” or “our”) uses cookies and similar technologies on our website at irdesign.co (the “Website”). It should be read together with our [Privacy Policy](#), which explains how we handle personal data more generally.

You can accept or decline non-essential cookies through **our cookie banner / your browser settings**. Strictly necessary cookies do not require your consent, because the Website cannot function properly without them.

▪ 1. WHAT ARE COOKIES?

Cookies are small text files placed on your device (computer, tablet or phone) when you visit a website. They are widely used to make websites work, to make them more efficient, and to give information to the site’s owners. We also use similar technologies such as pixels, tags and local storage; in this policy we refer to all of these as “cookies”.

Cookies may be:

- **Session** cookies, which expire when you close your browser; or **persistent** cookies, which remain until they expire or you delete them.
- **First-party** cookies, set by IRD; or **third-party** cookies, set by another organisation (for example, an analytics or embedded-content provider).

▪ 2. WHY WE USE COOKIES

We use cookies to:

- enable the Website to function and keep it secure;
- remember your preferences and settings;
- understand how visitors find and use the Website so we can improve it; and
- **where applicable** measure the effectiveness of our communications.

We do not use cookies to collect sensitive personal data.

▪ 3. THE CATEGORIES OF COOKIES WE USE

Strictly necessary	Enable core functions such as security, network management, page navigation and submitting forms. The Website cannot work properly without them.	No. Always active
Performance / analytics	Help us understand how visitors find and use the Website, which pages are visited and whether errors occur, so we can improve it.	Yes
Functionality	Remember choices you make (such as language or region) and enable embedded content such as maps, video or social media.	Yes

▪ 5. THIRD-PARTY COOKIES

Some cookies are set by third parties that provide services on our behalf or whose content is embedded in the Website, embedded video or maps, or social media features). These third parties process your data under their own privacy and cookie policies, over which we have no control, and we recommend you review them.

▪ 6. HOW TO MANAGE YOUR COOKIES

You can control and manage cookies in several ways:

- **Cookie banner / preference centre.** Accept, reject or change your choices at any time using the banner or a “Cookie settings” link on the Website.
- **Browser settings.** Most browsers let you view, manage, delete and block cookies through their help pages (for example Chrome, Safari, Microsoft Edge and Firefox). Blocking all cookies may stop parts of the Website from working.
- **Analytics opt-out.** You can opt out across all websites using the Google Analytics opt-out browser add-on.
- **More information.** For general guidance on cookies, see resources such as allaboutcookies.org.

▪ 7. CONSENT AND WITHDRAWING CONSENT

Where the law requires it, we place non-essential cookies only after you have given consent. You can withdraw consent or change your preferences at any time using **the cookie banner**. Withdrawing consent does not affect cookies already placed, but you can delete those through your browser. This approach is consistent with UAE Federal Decree-Law No. 45 of 2021 on the Protection of Personal Data and, where applicable, the EU GDPR and ePrivacy rules.

▪ 8. CHANGES TO THIS COOKIE POLICY

We may update this Cookie Policy from time to time to reflect changes in the cookies we use or for legal reasons. The “Last updated” date above shows when it was last revised.
